- 5. The processing of data shall be carried out in mixed form (both manual and automated) by the members of the Italian evaluation committee and by their foreign country counterparts, as well as by specifically appointed personnel at the aforementioned Office IX.
- 6. The data provided will not be communicated or sent to third parties, and will be stored for 10 years after the expiration date of the present call.
- 7. Interested parties may request access to and rectification of their personal data. Within the limits established by the current Italian legislation and subject to possible consequences on their participation in the selection, interested parties may also request the erasure of such data, as well as the restriction of or the objection to data processing.
